**STATEMENT OF POLICY AND FEES**  
*Effective 1-1-19*

**INITIAL APPOINTMENT—Constitutional Care (2½ to 3 hours)**

- ❖ Adults \$250
- ❖ Children (10 & under) \$220

*(NOTE: A deposit of \$100.00 will be required to hold your initial appointment and needs to be received within 10 days of your receipt of the initial consultation confirmation email. This deposit will be subtracted from your initial consultation fee.)*

**FOLLOW-UP APPOINTMENTS—Constitutional Care:**

- ❖ Regular Office or Phone Consult (up to 1 hour)      \$75
- ❖ Extended Office Visit (1 hour +)      \$95

**PAYMENT POLICY:** Payment for all homeopathic services is due and payable at time of service. I accept check, cash, debit or credit card (Visa, MC, Discover) online or in person through Square. *If your appointment is via phone or Skype, please note payment must be made via debit or credit card unless other arrangements have been made.*

**CANCELLATION POLICY:** *A 72 hour (3 business days) notice is needed to cancel an initial consultation appointment. If you cancel less than 72 hrs or fail to come to your appointment you will forfeit the initial \$100 deposit. A 24 hour cancellation notice is needed to cancel a follow-up appointment. If you fail to cancel or come to a follow up appointment, the charge is \$25.*

**ACUTE HOMEOPATHIC CARE:**

\$25 – \$50 (plus remedy) -----Symptoms per e-mail or telephone.

***(NOTE: An acute may require more than one e-mail or phone call and in that case there would be only one consultation charge)***

**REMEDY FEES:**

- ❖ Remedy charges range from \$8 to \$15 for dry/plussed remedies and \$18 to \$26 plus postage for LM remedies, depending on potency. Postage and handling for mailed remedies is \$6.

There will be no charge for questions or clarification regarding constitutional care between follow-up visits via email as long as no remedy is needed. If clarification would be better done via phone, I will contact the client. I will make every attempt to answer your e-mails or phone calls on the day you contact me. However, if I receive your message after 3 pm or evenings and weekends and it is not an emergency, I will respond on the following business day. **If you need emergency care, dial 911 or seek help at the nearest hospital Emergency Room.**
